# Message from Board Chair



2020 was a year of volatility, uncertainty. complexity, and ambiguity. The pandemic resulted in the closure of Cambodia to foreign tourists, financial economic and hardship for the Cambodian population, a lockdown of educational facilities, and many NGOs on the brink of extinction. At Anjali we stayed mission focused, keeping our goals for the next three years in mind:

- Overall becoming a learning center which is an indispensable part of the community
- **Growth** extending our services to 500 children and increasing the number of scholarship students to 50 over the next three years
- strengthening Quality quality of our programs and implementing the **OSCaR** program and case management software to increase our ability to monitor our programs and students' progress
- sustainability Financial transitioning our fundina approach to consist of 70% local and 30% international funding
  - Governance aiming to be certified for NGO Governance & Professional Practice (GPP) by the Cooperation Committee of Cambodia (CCC)

Although we have not been able 2020 has been a challenging year to achieve the progress we would have liked because of the staff, and Board. I am extremely pandemic, we have created a significant impact on community. We:

- Reorganized the delivery of our programs by introducing mobile library implementing virtual learning
- Supported our community by providing food packages and home garden training and supplies for the most vulnerable
- Strengthened the relationship with the Commune Chief through strong collaboration around food relief programs during the pandemic.

Although the number of COVID cases has been very low in throughout Cambodia the pandemic, the global lockdown enormously impacted has Cambodian society. As a Board we are monitoring the developments very closely and are aligning our support accordingly.

for Anjali House, its leadership, proud of Simon, Sophany and all the staff who have made it possible to shift quickly towards fulfilling our community's most pressing needs.

Without all the support we have received this year from our donors we would not have been able to achieve such an impact in our community. Our Emergency Food Relief fundraiser was a huge success and has enabled us to care for those who were most impacted directly bv the pandemic.

Finally. we have seen members retire from the Board. Francoise Callier and Nancy Barrett, and two new members join the Board. Welcome, Janine Barnes and Jessica Lim!



# Covid-Relief

While Cambodia was able to mitigate the number of coronavirus cases and prevent communal spread, it was heavily impacted economically. To prevent the spread of the virus, Cambodia quickly imposed entry restrictions, essentially banning international travel. The lack of tourists was devastating to Siem Reap's economy, where most businesses and jobs depend on tourism.

After assessing our families' needs, Anjali House arranged an Emergency Fundraiser to support those who were suddenly jobless and without income. We set a goal of \$28,280 and were able to raise \$33,141, allowing us to provide food and hygiene packages for our families for 10 months. Other Covid-relief efforts consisted of conducting home garden training and making our programs accessible by creating a mobile library and distance learning efforts.

# Our Programs

# Young Explorers

Our Young Explorers Program focuses on students 13 years old and younger and enrolled in local public schools. To help ease the financial burden associated with their education, we provide each Young Explorer with their mandatory school supplies and uniforms, as well as hygiene supplies.

The goal of the Young Explorers Program is to help children build a strong foundation for their future. Our supplementary education programs spark curiosity and creativity, and students develop critical life and learning skills. In addition to English and computer classes, Young Explorers learn about sustainable practices during weekly garden classes in our Anjali Community Garden.

Whether through visual art, sports, gardening, creative writing, dance, or music, we aim to foster each and every child's creativity. We emphasize field trips and developed smart partnerships with other NGOs like Angkor Photo Festival and Writing Though. These creative workshops help hone these skills by providing children with the opportunity to access various forms of expression, explore their interests, and develop their unique talents.





# 2020 Young Explorers Highlights

To prevent the spread of COVID-19, public schools closed in March 2020. Public school hours were reduced further from the already limited schedule of half a day. Students only attended school for a few hours a day twice a week and were responsible for completing homework at home for the remainder of the week.

Anjali House also closed its community center in March in accordance with government regulations. So our students could continue learning, teachers prepared weekly homework packets. Students or their parents came to Anjali House each week to pick up a homework packet. Teachers explained the exercises and the students had a chance to ask questions.

Online schooling poses a number of challenges. Poor internet connections and lack of devices made online courses difficult. For those that could attend, teachers held daily online classes so students could practice their skills. They communicated with their Anjali coach through services like Telegram and Facebook Messenger, allowing them to send questions, practice speaking with voice notes, and watch video lessons.

In August, Anjali gradually resumed some activities, while respecting COVID-19 safety guidelines. Small groups of students came in to use the computer lab to explore online science lessons created by our science volunteer. After completing the lesson, they completed fun science experiments, like making catapults, with our science volunteer. Before the new year we distributed mandatory uniforms, school supplies and hygiene packs for all students.

### Future Leaders

Our Future Leaders Program strives to equip students aged 14 and up with the skills they need to become successful, independent adults. To prepare these young leaders for their future, we provide English language and ICT classes, as well as specific workshops to develop critical soft skills such as time management, teamwork, and decision making.

Students seldom get the opportunity to explore different career paths. For this reason, after the age of 15, we connect students with local businesses to meet different professionals to inspire and mentor them. This ensures that they are making informed decisions about their future. We work closely with each student to encourage them and determine which professions and programs of studies align with their individual strengths and interests.

We also provide our oldest students with scholarships for extra tutoring in physics, math, biology, chemistry, and Khmer, which is critical to adequately prepare for and pass the national exams at the end of high school.

Finally, we provide counseling, scholarships, scholarship application support, and other resources for our oldest students to access higher education or vocational training after high school. We provide our scholarship students with computer and English classes and support them in finding meaningful part-time jobs or internships. Scholarship students also volunteer at Anjali or elsewhere in the community to continue to develop leadership skills. Because we stay in close contact with our scholarship students, they have a high graduation rate.





# 2020 Future Leaders Highlights

It was a difficult year for our Future Leaders. School closures and test postponements filled the year with uncertainty and confusion. Like the younger students, students only attended school for a limited schedule. They were responsible for completing homework and assignments independently for the rest of the week.

It was a particularly stressful year for grade 12 students because they must complete and pass the national exam to graduate from high school and begin university. This test generally takes place in August; however, the government postponed the test until December due to the pandemic. Following an additional outbreak of COVID-19, tests were again postponed in late November and rescheduled for January. Finally, the government canceled the exam on December 15th, allowing all grade 12 students to pass and begin their university applications!

While our center was closed, Future Leaders also participated in distance learning and online classes with Anjali House. Those students enrolled in the Access Program completed the program in November and attended a graduation ceremony with the American Ambassador, Patrick Murphy. These students were a great help with our Mobile Library program, helping design and present lessons to the community children. Despite the uncertainties, we provided scholarship support for our students to apply to universities. This year we extended the support to other students in the community by helping them find and apply for various scholarships.



### **Active Communities**

Khmer public school students only attend school for half the day. This often poses difficulties for working parents, who are forced to choose between earning an income to support their families or being at home for half of the day to watch their children. Anjali provides a safe and nurturing environment for these students when they are not in school, allowing parents to work so they can raise themselves, their families, and their communities out of poverty. Our social worker supports our parents by facilitating workshops and home visits to focus on parenting skills, mental health, health care, domestic violence, family budgeting, and job search assistance.

Anjali is committed to supporting the community as a whole, not only those with children enrolled in Anjali. Our social worker meets with the commune chief semi-annually, and we collaborate closely with schools and partner NGOs in the area. We host evening community English classes for students who are not part of Anjali's programs.

Community service is a part of our Future Leaders Program. Students participate and design projects to help serve the community they live in. Older students also volunteer as tutors for younger students at Anjali.




# 2020 Active Community Highlights

As an economy focused on tourism, the pandemic and shut down of global travel heavily impacted Siem Reap. In response to the pandemic, our social worker visited the families to see their situation and determine their needs. Other families came to Anjali House directly, showing they find it a safe place to turn to find solutions when things are difficult. Many families lost income and jobs, while others had to relocate to find a job. Some families returned to their hometowns to work in agriculture while waiting for schools and new jobs to appear in Siem Reap. School and community center closures posed an additional problem for parents with a lack of childcare. Students were home all day, preventing parents from working.

During home visits and small workshops, our social worker educated families about COVID-19 and taught them about social distancing and hygiene methods to protect themselves from the coronavirus. Our social worker also taught families about how to manage the increased levels of stress and anxiety caused by the pandemic.



# Report from the Board of Advisors



# Financial Summary




# Budget Expenses 2020




### Disbursements 2020

# REPORT OF INDEPENDENT AUDITORS ON THE STATEMENT OF FUNDS RECEIPTS AND DISBURSEMENTS - TO THE MANAGEMENT OF ANJALI HOUSE (CAMBODIA)

#### Opinion

We have audited the accompanying Statement of Fund Receipts and Disbursements of the Anjali House (Cambodia) for the year ended 31 December 2019 and notes to the financial statement, including a summary of significant accounting policies (together "the financial statement").

In our opinion, the accompanying Statement of Fund Receipts and Disbursements of the Anjali House (Cambodia) for the year ended 31 December 2019 is prepared, in all material respects, in accordance with the accounting policies set out in note 2 to the Statement of Fund Receipts and Disbursements.

#### Basis for opinion

We conducted our audit in accordance with Cambodian International Standards on Auditing (CISAs). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statement* section of our report. We are independent of the Anjali House (Cambodia) in accordance with the ethical requirements that are relevant to our audit of the financial statement in Cambodia, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

#### Responsibilities of management for the financial statement

Management is responsible for the preparation of the financial statement in accordance with the cash, receipts and disbursements basis of accounting described in Note 2 to the financial statement; this includes determining that the cash receipts and disbursements basis of accounting is an acceptable basis for the preparation of the financial statement in the circumstances, and for such internal control as management determines is necessary to enable the preparation of a financial statement that is free from material misstatement, whether due to fraud or error.

In preparing the financial statement, management is responsible for assessing the Anjali Home (Cambodia)'s ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Anjali House (Cambodia) or to cease operations, or has no realistic alternative but to do so.

#### NOTES TO THE STATEMENT OF FUND RECEIPTS AND DISBURSEMENTS For the year ended 31 December 2019

#### 1. General

Anjali House began life as a project of the Angkor Photo Association ("APA") (a registered non-profit association in France – Registration No: W751202186), and Angkor Photography Festival Association in Cambodia (Registration No: I391SPN). In 2005, a group of photographers got together to promote photography and highlight humanitarian issues in Southeast Asia. APA wanted to produce a regional photo festival but, in an area of so much deprivation, they also wanted to include some of the people who live in this remarkable and wonderful part of the world.

Anjali House (the "Organisation") provides to each child free healthcare, food, clean drinking water and education. For the year 2019, Anjali House supports around 120 children.

Anjali began with a one-off dance troupe, led by Sangeeta Isvaran, and a photography workshop initiated by Magnum photographer Antoine d'Agata. The children were encouraged to stay away from the streets, and at the end of the week, they performed their dance routine and exhibited their photographs to an international audience. With rapt applause, they found a sense of empowerment, pride and personal achievement.

Galvanized by the difference that was made in first weeks, APA was inspired to further extend its help, and began to provide education and practical support to Siem Reap's street children and engage with their parents.

The seeds of those efforts grew into the Anjali House of today. While close ties remain with the Angkor Photo Festival which provides annual photography workshops for our kids, Anjali House is now its own organisation with its own leadership.

The Organisation is an independent national NGO officially registered with the Ministry of Interior on 31 July 2006.

#### 2. Significant accounting policies

#### 2.1 Basis of preparation

The Statement of Fund Receipts and Disbursements is expressed in United States Dellar ("USD") and prepared under the cash receipts and disbursements basis of accounting modified to include certain receivables, payables and construction. Under the cash basis of accounting, grants and revenue are recognised when received rather than when earned and expenses are recognised when paid rather than when incurred.

#### 2.2 Receipts and disbursements

Receipts are defined as the funds received by the Organisation, net of bank charges from donors.

Disbursements represent all costs paid in line with the Organisation's objectives and the budget agreed.

#### 2. Significant accounting policies (continued)

#### 2.3 Fixed assets

The purchase costs of fixed assets are expensed upon acquisition. For control and management purposes, the Organisation maintains a fixed assets register.

#### 2.4 Staff health care payable

The Organisation has accrued USD 1,000 per year starting from 2017 to cover staff health care expenses. The Organisation will reimburse up to 100% of medical expenses for employees, with the maximum amount of reimbursement of USD 500 per year per employee. An employee may seek reimbursement from the Organisation if their medical expenses exceed 10% of their current monthly salary. However, expense related to enhancement of physical appearance will not be covered by the Organisation. Employees who are injured during working hours on Anjali House premises will receive 100% coverage for all medical expenses incurred.

#### 2.5 Foreign currency transactions

The Statement of Fund Receipts and Disbursements is expressed in USD. Transactions in currencies other than USD are translated to USD at the rates of exchange ruling at the transaction dates.
